# ANALYSIS OF NON-TIMBER FOREST PRODUCTS (NTFPS) UTILISATION AMONG HOUSEHOLDS IN CHIKUN LOCAL GOVERNMENT AREA OF KADUNA STATE

#### ABSTRACT

The study examined the analysis of Non-Timber Forest Products (NTFPs) utilisation among households in Chikun Local Government Area (LGA) of Kaduna State, Nigeria. Data were gathered through the administration of questionnaire to 96 randomly selected users from 8 purposively selected communities in 4 purposively selected wards of Chikun LGA. The data were analysed using descriptive statistics and mean score. The result of the analysis showed that the respondents were chiefly (52.9%) male, most (69%) of whom were married with average household size of 8 members, mean age of 40 years with secondary education (34.5%) and earned ₹35,300 per month on the average. Furthermore, spices/ condiments, medicinal herbs, sweetener and stimulants formed the basis for NTFPs utilisation in the study area. The result further showed that lack of awareness ranked 1st in the list of constraints. The study recommended the adoption of a more people-oriented forest-management approach through awareness creation by policy makers, value addition to NTFPs by households and organisation of training on sustainable utilisation of NTFPs.

### INTRODUCTION

**Forests** provide domestic subsistence consumption needs which increase disposable incomes to the households; serve as insurance premiums during times of economic hardships; and contribute to direct monetary benefits through sales [1]. Forests products can be classified in to Timber and the Non-Timber Forest Products [2]. NTFPs was defined by Opute et al. [3] as goods of biological resources, products and services other than timber which are collected from the forest ecosystem for survival and trade. They include fruits and nuts, vegetables, medicinal plants, gum and resins, bamboo, rattans and palms, fibres and flosses, grasses, leaves, seeds, mushrooms, honey and lac. NTFPs can also be referred to as all the resources or products that may be extracted from the forest ecosystem and are utilised within the household or marketed and have social, cultural or religious significance [4]. However, the sustainable utilisation of NTFPs is threatened by increasing household population. This research sought to analyse the various types and forms of utilisation of NTFPs in Chikun LGA because of the availability of NTFPs in the area.

#### MATERIALS AND METHODS

#### Study area

The study was conducted in Chikun Local Government Area of Kaduna State. It covers an area of about 445,659 km<sup>2</sup> and lies between latitude 10<sup>0</sup>13<sup>°</sup> 29<sup>°</sup> N and longitude 7<sup>0</sup> 2<sup>°</sup> 19<sup>°</sup> E of the Northern Guinea Savanna.

## Sampling techniques

A multi-stage sampling technique was employed in selecting the respondents. In the first stage,

Purposive sampling was used to select four (4) wards viz: Chikun, Kujama, Narayi and Nasarawa, out of the twelve (12) wards in Chikun LGA, due to the abundance of NTFPs in these wards. In the second stage, two (2) villages were purposively selected from each of the four (4) wards based on the prominence of NTFPs. Finally, random sampling was used to select twelve (12) households in each of the eight (8) selected villages to give a total of ninety-six (96) respondents. Out of the ninety-six (96) questionnaire administered to the respondents, eighty-seven were retrieved and used for the analysis.

#### Data analysis

Descriptive statistics and mean score were used.

#### RESULTS AND DISCUSSION

#### Socio-economic characteristics of households

Results in Table 1 showed that 33.3% of the households were between the age range of  $\leq 30$  years. This is closely followed by 31% who were between 41 - 50 years while only 20.7% and 14.9% of the households were in the age range of >50 and 31 to 40 vears respectively. The average age of the household was 40 years, meaning that they are in their youthful age. This implied that the youth population utilise NTFPs than the older population in the study area. The respondents' distribution by sex shows that about half (52.9%) of the households were males while their female counterparts were only 47.1% of the rural households' population. This implied that male headed households had NTFPs as their primary source of livelihood while their female counterparts prefer less tasking agricultural activities like processing. This is consistent with Balogun et al. [5]

"appraisal of perception on environmental forestry in Ebonyi State where 75% of the respondents were male. Majority (69%) of the household were married. Only 31% of them were single. This implied that family labour will be readily available for use in the assessment and collection of NTFPs in the study area. This is in line with the submission by Ganiyu *et al.* [6]. The classification by household size showed that there was an average of 8 members in a household and that 44.8% of them have 6-10 members. This is followed by those with 11-15 members (29.9%) and 1-5 members (25.3%). This confirms the use of family labour by the households in the study area. The result is consistent with the submission by Olagunju *et al.* [7].

The distribution of households by their level of education showed that 34.5% of them had secondary education. These were followed by those with non-formal education and tertiary education, representing 24.1% and 23.0% respectively. Only 18.4% of them had primary education in the study area. This implied that household in the study area will readily accept technology that can affect their utilisation capacity positively when given the opportunity. This conforms to Bankole *et al.* [8].

#### **Income level**

The income distribution of households in Table 2 showed that 32.2% of them earned between  $\aleph41,000 - \aleph50,000$  from NTFPs trade monthly in the study area. Only 26.4%, 21.8%, 10.3% and 9.2% realized  $\aleph31,000 - \aleph40,000$ ,  $\aleph21,000 - \aleph30,000$ ,  $\le \aleph20,000$  and  $> \aleph50,000$  per month respectively. This contradicts the submission by Solomon *et.al.* (9). This implied that income from NTFPs accounted for the major indicator of utilization in the study area.

### Occupation of the households

The major occupation of the households as seen in Table 3 is farming (37.9%). This is followed by civil servants (25.3%), Traders (18.4%), tailors (14.9%) and weavers (3.4%). This implied that many

households in the study area engage in the utilisation and sale of NTFPs and this ensures sustainable access to food and food security. This finding is in line with that of Suleiman *et al.* [10].

# Experience of the households in NTFPs utilisation in the study area

Almost half (40.2%) of the households in the study area had above 12 years of experience in the collection, trading and utilisation of NTFPs. This is followed by those with 9-12 years (32.2%) experience, 5-8 (18.3%) experience and 1-4 years (9.2%) experience. This implied that the trade and utilisation of NTFPs increased within the last 5 years in the study area. The abundance of these resources in terms of accessibility contributes in no small measure

to its collection for daily utilisation to secure the nutritional needs of the households as seen in condiments like locust bean. Household heads who are in these activities do teach their children to ensure that these activities are being transferred and sustained as alternative source of livelihood to guarantee food security. Households with more years of experience tend to be more cautious in the use of NTFPs with a view to ensuring its sustainability because they know that the wellbeing of their future generation is their social responsibility.

### **Cooperative membership**

The distribution of household head by cooperative membership showed that they are chiefly members (75.9%) of cooperative societies. Only 24.1% of them do not belong to cooperative societies in the study area. This means that the households involved in NTFPs utilization and trading in the study area will be

able to benefit from the services of cooperative societies in terms of access to loan for NTFPs business expansion and access to market information. This finding agrees with the assessment of Shea fruits processors in Niger State, Nigeria by Solomon *et al.* (9) where 94.7% of the processors were members of Cooperative societies.

# Major non-timber forest products (NTFPs) in the study area

The information on major NTFPs in the study area were extracted from the NTFPs used by the households. The study revealed that bush meat ranked 1<sup>st</sup> in the study area. This was closely followed by honey (2<sup>nd</sup>), spices (3<sup>rd</sup>), locust bean (4<sup>th</sup>), shea nuts and baobab (5<sup>th</sup>), medicinal plants (7<sup>th</sup>) and mushroom (8<sup>th</sup>). This could be because bush meat and honey

were found to be more lucrative among the other products in terms of revenue, implying that the households in the study area engage more in the collection, utilisation and trade of these products to meet their food need. However, this study considers the available resources hence only 8 products among others were selected. Below is the distribution of the NTFPs.

#### Forms of utilization of NTFPs

To ascertain the form of NTFPs utilization by households in the study area, a 3-point Likert-type scale of rarely, sometimes and often with a score of 1,2, and 3 respectively was used. A summation of scores for each respondent was determined and the point of average (2.2) and above was accepted High (H) while points below the aggregate score was

regarded as Low (L). As shown in Table 7, there is high index score with respect to utilization of NTFPs as spices and condiments (2.8), medicinal herbs (2.7), sweetener (honey) (2.6), stimulants (2.5) and fruits/vegetables (2.3) by the households. Since 5 utilization statements were significant (56%) out of the 9 statements, it implied that the households in the study area highly utilized NTFPs due to their access to NTFPs to meet their nutritional needs.

### Constraints to NTFPs utilisation by households

The constraints faced by the households in the utilization of NTFPs were shown in Table 8. From the table, lack of awareness on NTFPs utilization ranked 1<sup>st</sup>. This is closely followed by lack of training for products transformation (2<sup>nd</sup>) that will aid their use to meet household's food need. Seasonality of NTFPs, inadequate storage facility, lack of market information, variation in NTFPs distribution within

the forest and poor transport facility ranked 3<sup>rd</sup>, 4<sup>th</sup>, 5<sup>th</sup>, 6<sup>th</sup> and 7<sup>th</sup> respectively. This means that NTFPs are underutilized by the households in the study area to meet their food need, hence the need to enlightened them on the various uses. This corroborates the submission by Amusa *et al.* [11] on the marketing constraints affecting NTFPs trade in tropical lowland rainforest of South western Nigeria.

#### **CONCLUSION**

Based on the findings of the study, it was concluded that the users of NTFPs are farmers with average age of 40 years and mostly members of cooperative societies. The study further concluded that bushmeat was mostly utilised among households in the list of NTFPs. The findings also showed that there is high form of utilisation of NTFPs as spices/ condiments, medicinal herbs, sweetener and stimulants by the

households in the study area. It was finally concluded that lack of awareness on sustainable NTFPs utilisation ranked 1<sup>st</sup> in the list of constraints.

#### RECOMMENDATION

The study recommended the adoption of a more people-oriented forest-management approach through awareness creation by policy makers, value addition to NTFPs by household and organisation of training on sustainable utilisation of NTFPs.
